



Classical Christian Academy Partnership Agreement

Family Responsibilities and Expectations: This document outlines the responsibilities of CCA families. Please refer to the current CCA Handbook for full details.

Church Commitment

- At least one parent must be a confessed believer and actively involved in a local church.
- New families must submit a pastoral reference from a Christian church.
- Families enrolled for three or more years must submit a Follow-Up Questionnaire from their church.
- CCA may send follow-up questionnaires to confirm continued church involvement.

Educational Responsibilities

Home Teaching Commitment

- Families must implement assigned at-home lessons two or 3 days per week depending on track as directed by CCA teachers.
- Teachers are available by phone, email, or appointment to provide guidance and support.
- Families must follow the CCA Absence Policy regarding schoolwork completion.

Curriculum and Materials

- Parents are responsible for purchasing all required curriculum and supplies.
- Students may not begin classes without the required materials.
- Curriculum lists are posted on the CCA website by June 1.

Honesty and Transparency

- Parents must provide accurate academic, medical, and disciplinary history during enrollment.
- Full disclosure is required to ensure proper student placement and support.

Moral and Biblical Training

- Parents are responsible for their child’s spiritual and moral development in the home.
- CCA partners with families to reinforce biblical values.
- Upon admission, parents must have completed an approved parenting course or must complete one within one year of enrollment.

Financial Responsibility

- A Financial Agreement must be signed annually.
- Accounts must remain current for class attendance, grade access, and transcript requests.

- Accounts that are 40 or more days delinquent are subject to dismissal, and student records (excluding medical records) may be withheld.
- Families are expected to support fundraising efforts that help offset operational expenses.

Parent Training and Meetings

- New Parent Orientation and Curriculum Trainings prior to the start of school are required for all new families.
- Additional parent training may be required depending on curriculum or program participation.
- Three Parent Meetings are held each school year. Attendance is recorded.
- Families who miss required Parent Meetings may be required to meet with administration and may be assigned additional Parent Partner Days the following school year.
- Children are not permitted at parent meetings.

Parent Involvement and Serving Requirements

On-Campus Parent Partner Days

- New families are required to serve four Parent Partner Days per year (7 hours per day).
- Returning families are required to serve three Parent Partner Days per year.

History Day

- Participation in History Day is mandatory for all families for a minimum of five service hours.
- Failure to complete required Parent Partner Days or History Day obligations will result in fines and may impact future enrollment eligibility. Refer to the [Parent Partner Policy](#) on the CCA website for additional details.

Additional Ways to Serve

- Assisting before the start of the school year
- Coaching a sports team

Committee Service and School Events

- Families enrolled in four or more classes are required to serve on a school committee.
- Participation in required school events is essential to maintaining a strong partnership with CCA.

Important Notices

- Failure to fulfill partnership responsibilities may affect continued enrollment or re-enrollment eligibility. In the case of divorced/separated parents, the family will be treated as a unit, and parents must determine together how to satisfy these requirements. CCA will not mediate between parents.
- Fines may be assessed for missed Parent Partner Days, History Day obligations, or required meetings.
- Continued enrollment is contingent upon compliance with CCA policies and the successful maintenance of a cooperative partnership.
